

NOTICE OF RATE INCREASE AND PUBLIC HEARING

NOTICE IS HEREBY GIVEN that on May 10, 2017, the Board of Directors (the "Board") of Lockwood Area/Yellowstone County Water and Sewer District, Montana (the "District"), adopted a Resolution of Intention to Increase Rates for the Users of the District's Water and Sanitary Sewer Systems (the "Resolution").

This notice was mailed to all District customers on May 12, 2017. The notice of the passage of this resolution was published in the Billings Times, (May 11th & May 18th, 2017), and the Yellowstone County News, (May 12th & May 19th, 2017).

The District currently charges users of the Water System a monthly base rate (the "Water Base Rate") based on the size of the water meter servicing each connection. The District also charges users of the Water System a usage charge per 1,000 gallons per month (the "Water Usage Rate"). The monthly water charge ("Monthly Water Charge") for each connection consists of the Water Base Rate plus the Water Usage Rate for each connection. The District proposes to increase the Water System Base Rate and Water Usage Rate July 1st of each year over the next four years as follows:

The District also charges users of the Sanitary Sewer System a usage charge per 1,000 gallons per month of water (the "Sewer Usage Rate"). The monthly water charge ("Monthly Sewer Charge") for each connection consists of the Sewer Base Rate plus the Sewer Usage Rate for each connection.
