MINUTES OF REGULAR MEETING OF BOARD OF DIRECTORS OF LOCKWOOD WATER AND SEWER DISTRICT

March 9, 2022

The regular meeting of the Lockwood Water and Sewer Board of Directors was held on March 9, 2022 following the Public Hearing on the Phase 3 Boundary. President Peters called the meeting to order at 8:30 p.m. in the Lockwood High School Community Room, 1932 Highway 87 E, Billings, Montana, 59101.

Present at the meeting were Board members Carl Peters, Merrill Walker, Carlotta Hecker, Stuart Deans, and Scot Bowen. Also present was Manager Mike Ariztia, Assistant Manager Tony Reed, Jill Cook of Morrison-Maierle, Inc., and Evelyn Pyburn of *Yellowstone County News*.

- **3.** The February 9, 2022 Board meeting minutes were presented for approval. No corrections were noted.
 - 1. Carlotta Hecker moved to approve the February 9, 2022 Board minutes as written. Merrill Walker seconded the motion. Motion carried.

4. Resolution No. 171, creating and establishing its Phase III Sewer Subdistrict

After discussion of the information and comments brought forward in the Public Hearing, it was decided that the acceptance or change of Resolution No. 171 should be tabled until the April 13, 2022 meeting.

II. Scot Bowen moved to cancel the decision on Resolution No. 171 until the April 13, 2022 Board meeting. Stuart Deans seconded the motion. Motion carried.

Mike Vinton reiterated that he wanted to be excluded from the project at this time.

Manager Ariztia will contact bond counsel to confirm the proper process is being utilized for Phase III, and also how to proceed in view of the new developments.

5. Approval of Pay Application No. 12 to Record Steel and Construction, Inc. (RSCI) for the 2020 Water Treatment Plant Upgrade Project.

RSCI Pay Application No. 12 was submitted for the 2020 Water Treatment Plant Upgrade, covering services rendered 2/1/2022 through 2/28/2022 in the amount of \$904,738.93.

III. Stuart Deans moved to pay RSCI Pay Application No. 12 in the amount of \$904,738.93, for services rendered 2/1/2022 through 2/28/2022. Merrill Walker seconded the motion. Motion carried.

6. Approval of Change Order No. 4 to the 2020 Water Treatment Plant Upgrade Project.

Change Order No. 4 involves a credit to the overall cost of the project. It covers two UVT Monitors that were originally thought to be needed and later found they were not. There was also additional expense to the Treatment Plant in the amount of \$2860 to relocate the existing hot water heater to accommodate the installation of the variable frequency drives. FRP paneling was also changed from Class A to Class C. The net change with the addition of the water heater location, the credit for the UV Analyzers, and the credit to change the FRP paneling resulted in a decrease of cost to the project of \$9,113.58.

IV. Scot Bowen moved to approve Change Order No. 4 to the 2020 Water Treatment Plant Upgrade for a credit to the project of \$9,113.58. Merrill Walker seconded the motion. Motion carried.
